East Run Opens Access to Needed Health Care Services in St. Mary's

Bringing new care options to southern St. Mary's County, the East Run Center in Lexington Park officially opened in March 2018. The first floor of the 45,000-square-foot facility is dedicated entirely to health care.

"MedStar Health's \$2.3 million investment to build out East Run brings much needed, convenient access to primary care, care coordination, behavioral health services, a laboratory, Health Connections classes and programs, and eventually dental to our community," said Stephen Michaels, MD, FACHE, chief operating officer and chief medical officer of MedStar St. Mary's Hospital. "We understand the importance of this project to the revitalization of Lexington Park and the economic driver that has been established."

Community partners in East Run's development included The Cherry Cove Group, Walden Sierra, the Department of Social Services, the Southern Maryland Center for Independent Living, the Minority Outreach Coalition, the St. Mary's County Housing Authority, the Community Development Corporation, the Health Department, and many branches of St. Mary's County Government.

"Our hope," said Dr. Michaels, "is that East Run will make it easier for everyone in the southern end of the county to receive quality care close to where they live and work."

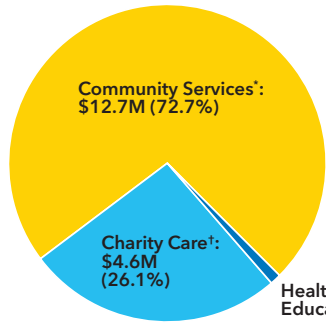
Putting patients first is the driving force of MedStar St. Mary's. After 107 years, we remain proud to serve our neighbors, family, and friends.
